The City Council of the City of Springville met in a rescheduled workshop session on Monday, January 4, 2022 at 5:30 p.m. at Springville City Hall. Mayor Dave Thomas presided and City Clerk Lynn Porter served as recording secretary.

Attorney Watson explained to the City Council that the opioid settlement agreement is with one of the defendants involved.

Mayor Thomas asked Ecosouth representative Bryan Stephens if there was any alternative to hand loading brush, and was told no. The City's specifications say household brush should not exceed four feet in length or four inches in diameter.

Councilmember Toles stated nothing is being picked up now.

Mr. Stephens stated he has trucks picking up brush every Saturday. He stated there is a backlog on this type of equipment. Right now the earliest he could expect delivery of a garbage or a knuckle boom truck is 2023 to 2025 depending on the truck.

Councilmember Reaves stated she has received many calls. Garbage was extremely far behind when they took over, and now that is caught up. Now they are working to pick up brush.

Councilmember Parker asked about pickup of couches and mattresses, and Mr. Stephens said they would be picked up.

Councilmembers toles and Vinson each expressed that there are no longer problems with garbage.

Councilmember Reaves stated if the brush is too big to be picked up, it should not be out there.

Mayor Thomas stated there is responsibility on the customer's part not to put large debris on the curb.

Mr. Stephens stated they will start tagging piles that are out of compliance. His number will be given for follow up so that the City does not have to deal with the calls.

Councilmember Toles stated that one end of Purple Heart Boulevard looks good, but the other end is not good.

Public Works Director Earl Peoples stated we need to lay the bank back to widen the road. Right now we do not own the property, but we will. The projected cost to move the road and the utilities is \$250,000 to \$275,000.

Councilmember Toles stated we do not need to make this a freeway. Widening the road will encourage more traffic to use Purple Heart as a cut through.

Mr. Peoples stated this will be a by-pass road. It needs to be 22' to 24' wide at a minimum. This widening is needed up to the church.

Councilmember Toles stated the sidewalk does not need to be taken up.

Mr. Peoples stated it may have to be taken up and replaced.

Zoning Director Maranda Nolen stated the Planning and Zoning Board has recommended a replacement to fill the vacancy created by member Frank Agnew stepping down. She asked that the appointment of Joey Breighner to fill this unexpired term be added to the agenda.

Mayor Thomas discussed the school traffic situation saying all we are doing is shifting the problem from Academy Drive to Forest. There was a traffic jam this morning, but it was better this afternoon.

The workshop was concluded.

Mayor Thomas called the meeting to order. Pastor Brad Smith of Spring Valley Baptist was called upon to give the invocation, followed by the pledge to the flag.

The minutes of the December 20, 2021 meeting were presented for approval. Councilmember Toles moved they be approved, seconded by Councilmember Vinson, and the motion carried.

The agenda was presented for approval. The Planning and Zoning Board appointment was added to the agenda. Councilmember Reaves moved the agenda be approved as amended, seconded by Councilmember Walker, and the vote was unanimous.

Councilmember Reaves moved Resolution 2022-01 awarding a three-year garbage contract to Ecosouth be approved, seconded by Councilmember Hennings, and the vote was unanimous.

Councilmember Vinson moved Resolution 2022-02 approving the settlement agreement with Endo Pharmaceuticals be approved, seconded by Councilmember Toles, and the vote was unanimous.

Councilmember Walker moved Joseph (Joey) Breighner be appointed to fill the unexpired term of Frank Agnew on the Planning and Zoning Board. This was seconded by Councilmember Parker and the vote was unanimous.

Mr. Breighner was recognized and thanked the Council for their kind words. He committed to serve to the best of his ability.

Mayor Thomas stated he had a report that is not city business, but as of this morning, he has filed paperwork to become a candidate for the Republican nomination for Governor.

No other business coming before the Council, Councilmember Vinson moved the meeting be adjourned, seconded by Councilmember Toles, and the vote was unanimous.
